**DRAFT Minutes of AGM of League  
1930h Wednesday 20<sup>th</sup> August 2008**

<b>1.0</b>	<b>Roll Call</b>
	All teams were represented.
<b>2.0</b>	<b>Adoption of Accounts</b>
	Agreed. Accounts for financial year ended 30 <sup>th</sup> June '08 were approved.
<b>3.0</b>	<b>Formal Resolutions.</b>
	<p>Resolved.</p> <p>1.0 Should any player, official, team or club be found guilty by the Football Association (or any of its appointed bodies) of acting in a manner deemed to be improper (or any charge related there under), then that player, official, team or club (as appropriate) shall be automatically expelled from the league. Where a team is expelled under these circumstances, its record in its appropriate division shall be expunged. Where any player, official, team or club be so found guilty at a cup match organised by the league, then that team shall be dismissed from the cup competition and the tie shall be awarded to the opposition.</p> <p>2.0 Any parent, guardian or other relation of a player found by the Football Association (or any of its appointed bodies) to have breached the standards of behaviour outlined in the Parents Charter shall be banned by the league from attending any future match organised by the league involving either of the two teams concerned. Where team plays on a public facility, and a future match is attended by a person so banned, then the referee shall be instructed to abandon the match and to make a report to the Football Association copied to the League.</p> <p>3.0 That all players registered to play at Under 9 level must reach the age of 9 between 1<sup>st</sup> September and 31<sup>st</sup> July during that season. This means that no player eligible to play at Under 8 level can be registered to play at Under 9 level.</p> <p>4.0 Contract players, as defined in Football Association Rules, are not permitted in this competition. No player registered with an FA Premier League or Football League Academy or School of Excellence will be permitted to play in this competition. A Player registered with a Centre of Excellence may only play in this competition subject to the regulations of the Programme for Excellence.</p> <p>The meeting rejected a number of other proposed resolutions dealing with a) membership of the management committee b) expulsion from the league of clubs giving memorabilia to players in development competitions c) expulsion for encroachment on to the field of play and d) dismissal from the field of play.</p>
<b>4.0</b>	<b>Election of Officials</b>
	The AGM agreed to elect officials as follows; Chair Kelly Scott; Secretary Kevin Richardson; Treasurer Jayne Davison; Fixture Secretary Dave Lattimer. The AGM also agreed to elected representatives from the following clubs to the management committee; Heaton Hawks, Newcastle City Juniors, Westgate and Red House Farm. One position remained vacant. .
